# Perpetual Investments launches Trillium ESG Funds in Australia

Perpetual Investments is pleased to launch two environmental, social and governance (ESG) products to the Australian and New Zealand market – the Trillium ESG Global Equity Fund and the Trillium Global Sustainable Opportunities Fund.

The Trillium ESG Global Equity Fund is an actively managed, diversified portfolio of global equities that provides the potential for long-term capital growth by investing in companies that are leaders in managing ESG risks and opportunities. This fund has a comparable investment strategy to an existing US Trillium fund, of the same name, offered by Trillium Asset Management, LLC (Trillium) to United States residents for approximately 20 years.

The Trillium Global Sustainable Opportunities Fund is actively managed with a concentrated highconviction, sustainability-themed strategy that invests in companies positioned to thrive during the ongoing transition to a more sustainable economy. This fund invests in companies contributing to three core sustainability themes through their core business:

- climate solutions
- economic empowerment
- healthy living.

"The interest in ESG globally has accelerated in recent times as a consequence of the COVID-19 pandemic, as well as locally with the extreme climate events recently experienced in Australia. There has also been strong interest in Trillium's ESG offering from institutional investors, asset consultants and private clients in the months since we announced our acquisition of Trillium," said Perpetual Global Head of Distribution Adam Quaife.

"We are proud to now offer Australian and New Zealand investors access to Trillium's integrated ESG approach, which has the objective of providing investors with long-term capital growth through investment in global companies. This fits comfortably with Perpetual Investments' focus on fundamental research and analysis of quality, value and risk."

Trillium's rigorous selection criteria is fossil fuel free and integrates financial and ESG research to seek high-quality growth companies at a reasonable price, resulting in equity portfolios that seek positive risk-adjusted long-term investment performance.

Perpetual Limited completed its acquisition of Trillium a specialist ESG investment firm based in Boston USA, on 30 June 2020. The Trillium ESG Global Equity Fund and the Trillium Global Sustainable Opportunities Fund are the first Trillium funds to be offered to Australian and New Zealand investors.
